SCOPE OF THIS POLICY

Rossmann & Co./pcb has created this privacy policy in order to describe how we collect, use, maintain, share, and protect your personal information when you use our website, www.rossman-pcb.com, or payment portal, www.paypcb.com. This privacy policy applies to information collected when you visit our website or payment portal. It does not apply to information collected in any other way, including information collected offline.

CHILDREN'S PRIVACY

The Rossmann & Co./pcb website located at www.rossman-pcb.com (its "website") and www.paypcb.com (its "payment portal") are not intended for individuals less than the age of eighteen and Rossmann & Co./pcb does not knowingly collect data relating to individuals less than the age of eighteen.

THE FEDERAL FAIR DEBT COLLECTION PRACTICES ACT

Nothing in this privacy statement is intended to contradict your rights under the Fair Debt Collection Practices Act. Rossmann & Co./pcb will not disclose any information to third parties that is otherwise prohibited by the FDCPA.

INFORMATION AUTOMATICALLY COLLECTED

When you visit the website, we automatically collect certain information, like your IP address, browser type and operating system, the domain from which you came, the page you are viewing, and the date and time of your visit ("usage data").

We use this information for a number of purposes, such as investigating security incidents, running analytics to understand usage, and for compliance with security standards.

PERSONAL INFORMATION

We do not collect personal information when you visit our website, unless you choose to provide it to us. You may elect to share personal information with us by filling out the information on our Contact page, such as name, address, phone number, email address, and any other personal information you choose to provide. B. Protected classification characteristics	Age (40 years or older), language, marital status, medical condition (including gender, gender identity, gender expression, pregnancy, conditions), sexual orientation, veteran or military status.
C. Internet or other electronic network activity information	Browsing history, search history, and information regarding a consumer's use of an Internet or other electronic network, such as a website, application, or advertisement.
D. Sensory data	Audio.
E. Professional or employment-related information	Current or past job history.
F. Inferences drawn from any of the information identified above	Profile reflecting a consumer's preferences, characteristics, psychographic traits, attitudes, intelligence, abilities, and aptitudes.

HOW WE USE YOUR INFORMATION

Personal information is collected solely for the purpose of debt recovery in a lawful manner and remains part of our records until we determine the information is no longer needed, or we are

required by law to delete such information. We will collect the minimum amount of data necessary to effectuate debt collection. Your personal information may be used to fulfill or meet the reason you provided such information. For instance, we use information you send to us to respond to your inquiries or comments.

Your personal information will also be used to perform services on behalf of the business or service provider, including maintaining or servicing accounts, providing customer service, verifying customer information, processing payments, providing analytic services, or providing similar services.

We will not collect additional categories of personal information or use the personal information we collected for materially different, unrelated, or incompatible purposes.

SALE OF PERSONAL INFORMATION

We do not sell and will not sell your personal information.

SUBSCRIBER MOBILE NUMBERS

No mobile information, including text messaging originator opt-in data and consent, will be shared with third parties/affiliates for marketing/promotional purposes.

HOW WE COLLECT YOUR INFORMATION

We collect most of this personal information directly from our clients for whom we provide services to, as well as from you by telephone, written correspondence through the mail, email or fax, by viewing public social media/network pages, or other information available online. However, we may also collect information:

- From publicly accessible sources (e.g., property records or court records);
- From your transactions with us;
- From our service providers (e.g., letter vendor, location vendors, payment processing vendors, call analytics vendor, and/or electronic signature service provider);
- Directly from a third party (e.g., third parties contacted during location activities pursuant to 15 U.S.C. §1692b, such as your friends, neighbors, relatives, and/or employer);
- Consumer reporting agencies (CRAs)
- From a third party with your consent (e.g., your authorized representative and/or attorney); and
- From activity on our website.

GOOGLE ANALYTICS

We use a tool called “Google Analytics” to collect information about use of this site. Google Analytics uses cookies and similar technologies to collect information such as how often users visit this site, what pages they visit when they do so, and what other sites they used prior to coming to this site. We do not combine the information collected through use of Google Analytics with personal information.

We use the information we get from Google Analytics to understand how our website is used and make improvements.

COOKIES

We use cookies to collect website usage data, to improve the site and our services, as well as your experience with the site. Cookies are pieces of information generated by a web server and stored in your computer. Rossman & Co./pcb only uses session cookies. A session cookie is deleted when you close the browser. You can control cookies through your browser settings and other tools.

Rossman & Co./pcb thereafter deletes or anonymizes such information in accordance with applicable laws.
